### BRUNSWICK HILLS TOWNSHIP TRUSTEES REGULAR MEETING October 9, 2018

The Brunswick Hills Township Board of Trustees met in regular session on Tuesday, October 9, 2018 at Brunswick Hills Township Town Hall.

Board of Trustees Chair, Michael Esber, Vice-Chair John Witthuhn, Trustee Christina Kusnerak, Fiscal Officer Katherine Esber, Zoning Inspector Evelyn Czyz, Foreman Paul Magovac, Fire Chief Anthony Strazzo and Police Chief Tim Sopkovich.

Esber called the meeting to order at 7:03 PM and noted the meeting was properly advertised.

## **PRESENTATION:**

Eagle Scout presentation for Dylan J. Bell, Resolution 32-2018.

Chris from the Auditors office announced two contests being sponsored. The first one is, Top Dog, this is for fourth graders to write an essay on their favorite dog alive and living in Medina County. Top Dog essay is due November 5<sup>th</sup>, 2018. The second is Seals, for high schools students. Seal essay is due November 21<sup>st</sup>, 2018.

Beth Schnabel gave a twenty-three minute presentation on the history, purposed future project of, Bike Medina County organization. The township will wait for additional information in reference in designating roads as bike roads.

## **DEPARTMENT REPORTS**:

## Zoning Department:

Zoning Inspector Czyz gave the activity report for the month of September. Monies collected is \$2,237.95. Mrs. Czyz advised the board of a joint effort by BHPD, MC Building, Electric and Health department, EPA and her office to get a problematic property under control. The office will be closed on October 26<sup>th</sup>, 2018 and November 2<sup>nd</sup>, 2018 for the zoning inspector to attend training.

Esber stated that he and the zoning inspector are looking into the possibility of a property maintenance code. There have been several complaints about tall grass, noxious weeds and other issues with unkempt property. ZI Czyz has obtained and forward Montville Townships code for review.

Esber read a letter of accolades from a resident who received assistance from Evelyn Czyz when asking about property off Marks Road. The letter indicated Mrs. Czyz went above and beyond what was expected.

The Board of Trustees will hold a public hearing on October  $23^{rd}$ , 2018 at 5:30 PM to hear thoughts and concerns about the purposed rezoning of property located on West  $130^{th}$ .

## Service Department:

Magovac inquired about purchasing a salt barn this year. The board and Magovac discussed the possibility as well as the size and cost of the barn. Esber asked if permission was received from Ohio Edison. Magovac explained that permission was covered. With all in agreement of the need, Magovac is permitted to proceed with gathering estimates.

Magovac explained to the board that this is the last year the township can borrow a roadside mower. Due to the cost of repairs and damages to equipment other entities are no longer willing to take to risk of any costly replacement and/or repairs. The purchase of a roadside mower is a 2019 budget item.
