No other nominations. <u>Roll Call to elect Matthew Mickas to Vice Chair for 2018</u>: Mrs. Jenkins-yes; Mrs. Kijek-yes; Mr. Fulkerson-yes; Mrs. Porter-yes. Motion carries to elect Matthew Mickas as Vice Chair.

## **Review and adoption of the Zoning Commission Bylaws**
