# Brunswick Hills Township Zoning Commission Organizational Meeting Minutes January 12, 2023

## **Call Meeting to Order**

#### 1. Swearing in of Board Members by Trustee

#### 2. Acceptance of Nominations for Chairperson

Mrs. Wetterman asked if there were any comments on the Comprehensive Plan. Mrs. Czyz stated that the Township had applied for a grant to assist with the revision of the Comprehensive Plan. Trustee Murphy stated at the January 10, 2023 Trustee Meeting, that we had been awarded a \$5000.00 grant that will help with the Comprehensive Plan project. Trustee Kusnerak had applied for the grant a couple of years ago. Thank you to the trustees for their efforts. That will help. The Township will have 2 years to complete the Plan.

Mrs. Wetterman asked for a motion to accept the Comprehensive Plan as written.

<u>Motion</u>: Mr. Kelly moved to re-adopt the township <u>Comprehensive Land Use Plan</u>. Mr. Kuenzer seconds. <u>Roll Call</u>: Mr. Kuenzer-yes; Mr. Kelly-yes; Mrs. Wetterman-yes.

Mrs. Wetterman asked if the first Thursday of the Month at 7:00 p.m. was alright with everyone for the meetings.
