In the enforcement of this resolution, within its powers the Board of Zoning Appeals may reverse or affirm fully or part or modify the requirement of decision and determination as its in opinion ought to be done and in the end shall have all the powers of the officers and bodies from the appeal has taken and may issue or direct issuance of a certificate.

Mr. Schigel advised we are here specifically in regards to Mr. Humphreys visit on the zoning citation on February 26, 2024.

Mr. Richter advised that it is his understanding that they are going to withdraw this appeal and formally withdraw the conditional use application as well.

Mr. Henry stated that this is correct. He stated his name as Phil Henry (Mr. Destro's attorney) and that at this point the issues have been resolved.

Tony Destro was sworn in and stated his address as 301 Marks Rd. Mr. Henry advised that he has spoken and discussed this with Mr. Richter and Mr. Humphrey in the back as far as where they stand with the permit for conditional use as well as the appeal and the issues have been resolved. Mr. Henry stated that they will be formally withdrawing the application and appeal and stated he appreciates their time.

Mr. Schigel asked Mr. Richter if there is anything else they need to do and Mr. Richter advised that there is not.

Mr. Kersten asked if the violations are being taken care of and asked Mr. Humphrey if he had a chance to go out there (to Mr. Destro's property) Mr. Humphrey stated yes and that he was there around 1 to 1:30pm today and took pictures and it wil be good. Mr. Kersten asked if it's up to his satisfaction and if he is good with everything that's going on. Mr. Humphrey stated yes.
