

## RESOLUTION 30-2026

### BRUNSWICK HILLS TOWNSHIP RESOLUTION PROVIDING GROUP INSURANCE PLANS FOR ALL ELIGIBLE EMPLOYEES AND ELECTED OFFICIALS OF BRUNSWICK HILLS TOWNSHIP

**WHEREAS**, the Board of Trustees of Brunswick Hills Township met in regular session on Tuesday, March 24, 2026, commencing at 7:00 PM;

**WHEREAS**, the Ohio Revised Code provides that the Board of Trustees of Brunswick Hills Township can provide group insurance plans for all eligible township employees and elected officials; and

**WHEREAS**, Brunswick Hills Township has full-time employees and elected officials wishing complete insurance; and

**WHEREAS**, said approval must be granted prior to any elected official taking office.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Trustees of Brunswick Hills Township that the township group insurance plans will be in effect for those eligible full-time and elected officials according to State law and the current employee personnel policies and procedures handbook. Brunswick Hills Township hereby offers coverage for all health care benefits listed in ORC 505.60 including hospitalization, surgical care, major medical care, disability, dental care, eye care, medical care, hearing aids, prescription drugs, sickness and accident insurance, or life insurance, as the Board so decides, under one or more group insurance policies. In accordance with the employee personnel policies and procedures handbook, the premium for both individual and family coverage is paid for by the Township at A SET RATE and by the employee at a SET RATE for the year 2026 and going forward which can be adjusted by the Board of Trustees.

**BE IT FURTHER RESOLVED** by the Board of Brunswick Hills Township, that non-union full-time employees and elected officials shall contribute the SET RATES as outlined below to participate in the group insurance plans outlined in this Resolution:

<b>Medical</b>	
Individual	15% of the premium
Married	15% of the premium
Family	15% of the premium
<b>Dental</b>	
Individual	19% of the premium
Married	18% of the premium
Family	23% of the premium
<b>Vision</b>	
Single	0% of the premium

Married	0% of the premium
Family	0% of the premium

**BE IT FURTHER RESOLVED** that the Board of Trustees of Brunswick Hills Township Resolves to provide Group Insurance Plans for All Eligible Employees and Elected Officials of Brunswick Hills Township going forward unless adjusted by the Board of Trustees
