

**Brunswick Hills Township
Zoning Commission Public Hearing Minutes
July 30, 2026**

Call Meeting to Order

Mr. Witt called the Brunswick Hills Township Zoning Commission Public Hearing on July 30, 2026 to order at 7:00 PM for the purpose of receiving public comment on the proposed Zoning Resolution amendment to remove marijuana related language from the Township Zoning Resolution.

A roll call of the board was executed.

Mr. Witt asked all present to stand. He asked the commission and attendees to observe a moment of silence in honor of Mr. David Smerek, who served on the commission and passed away recently, Mr. Smerek will be greatly missed.

PURPOSE OF PUBLIC HEARING

Mr. Witt stated that the purpose of the public hearing is to receive public input on the proposed Brunswick Hills Township Board of Trustees amendment to remove marijuana related language from the current Zoning Resolution. He noted the purpose of the meeting is public comment and opened the floor to comment.

PUBLIC COMMENT:

No members of the public stepped forward to comment.

COMMISSION DISCUSSION:

Mr. Kalina noted that the Medina County Department of Planning Services had not yet reviewed the proposed language change at the time of this hearing. He stated that the Planning Commission is scheduled to consider the matter the following week, and that while the commission is not required to follow the Planning Commission's recommendation, it is required to take the feedback into consideration before acting. Given that the Planning Commission's recommendation had not yet been received, Mr. Kalina stated that the commission should not take a final vote at this meeting and recommended continuing the public hearing to August 6, 2026 at 6:30 PM, at which point the Planning Commission's recommendation would be available.

Motion: Mr. Kalina made a motion to continue the public hearing on the proposed Zoning Resolution amendment to remove cannabis and marijuana related language to Thursday, August 6, 2026 at 6:30 PM. Mr. McFarland seconded the motion.
